## FCCLA CHAPTER MAKES A DIFFERENCE

This past year the Dell Rapids FCCLA Chapter took part in a fundraising project through the We Help Two organization. By participating in this you can impact the local community by raising funds for a local charity plus giving a local sock donation to those in need. On several occasions the chapter sold funky socks. When people purchased a package of three socks they voted for a choice of local charities. Since the vote was very close, it was decided that the funds raised would be donated between the choices which included the Dell Rapids Food Pantry, SD Make-a-Wish Foundation, and Feeding South Dakota. Since the We Help Two has other ways to partner to make positive changes in the world, the chapter decided to donate some of their profits to the Water for Africa project. The funds that we donated provided a new artesian water well for the entire village of Kiniga, Rwanda that has a population of 1,020. Concrete structures and new pipes were constructed to ensure a constant flow of clean water and to protect livestock from contaminating the area. Now the excess water runoff exits the concrete basin and is used for irrigating crops in the nearby fields. Before this was constructed the old water source was nothing more than a mud pit with some dirty water on the surface. The people would have to use small cups to scoop out a little water at a time to fill their water cans. The water that they did collect was full of green algae, sediment, and even small red worms. Everyone in the village had to drink this water and it was a constant source of sickness that would keep children from going to school.

## **ACTIVITY TICKET POLICY**

The cost of an individual high school student activity ticket is \$20.00, and the cost of a middle or elementary student activity ticket is \$15.00. Activity tickets allow all-season admittance to most athletic and fine arts events conducted by the Dell Rapids Public School and can serve as identification for student prices at other activities. Activity passes can be purchased through My School Bucks at myschoolbucks.com, click on the Store.

A family all-season athletic pass is available for \$100.00. A family pass will include up to two adults (must be a parent or guardian) and all K-12 children living in one household. Other options for admittance to school activities include the adult 10-punch athletic pass for \$30.00 or adult all-season athletic passes for \$50.00 each. Regular contest athletic competition admission prices are \$5.00 for adults and \$3.00 for students, and \$6.00 and \$4.00 for double-header games, respectively. Senior citizens (age 62 and over) will receive free admission for most Dell Rapids Public School activities (no pass needed).

Activity passes are non-refundable.

## ANNUAL ASBESTOS NOTIFICATION

In compliance with the U.S. Environmental Protection Agency (EPA) Asbestos Emergency Response Act (AHERA) in the summer of 1998, we preformed inspections of our school buildings for asbestos containing building materials (ACBM) The inspection findings and asbestos management plan have been on file in the school administration office since that time.

The EPA requires us to perform re-inspections of the ACBM every three years and six month surveillances each year for any change in condition of the ACBM. An accredited management planner reviewed the results of the re-inspections and recommended actions we should take to safely manage the ACBM in our buildings.

The ACBM in this school is in good condition and we will continue to manage them in place as recommended by the accredited management planner. We plan on taking whatever steps are necessary to ensure your children and our employees have a healthy and safe environment to learn and work in.

The results of the most recent inspect preformed July of 2021 are on file in the school administration office. Everyone is welcome to view these anytime during normal school hours (Monday through Friday 8:00am-4:00pm). ## **Ag In Action**

Summer break is always busy with various activities and events. Hopefully everyone was able to find a little time to relax and rejuvenate. The start of the new school year is exciting because you start with a clean slate. You get a chance to correct the mistakes that you made the previous year. You get to build on your successes and learn from your failures.

A quote by Thomas Jefferson states "Agriculture is our wisest pursuit, because it will in the end contribute most to real wealth, good morals and happiness." However, today the agriculture industry is facing huge challenges, from rising costs of supplies, a shortage of labor, and changes in consumer preferences for transparency and sustainability. That is why agriculture education is so important as everyone relies on agriculture for things we need every day. Skills learned in the agriculture classes help to build the foundation for educated consumers and agriculturists.

The agriculture classes offered for the fall semester include two sections of Introduction to Agriculture, Food and Natural Resources. One section will be during 2nd block and the other will be during 4th block. Those students will explore the role of the FFA organization in Agriculture Education, define and discuss the concepts of natural resources, demonstrate an understanding of animal science systems, demonstrate an understanding of plant structure and function, relate basic food science technology principles to production agriculture, summarize basic food science technology, and summarize basic principles involved in agricultural systems technology. Those students will also have the opportunity to learn about shop tools and shop safety, project design and construct a small wood project. This class will last the entire semester and will be worth one credit toward graduation.

Fundamental Animal Science will be offered during the first half of 3rd block. The students in this class will apply knowledge of anatomy and physiology to produce and/or manage animals in a domesticated or natural environment; recognize animal behavior to facilitate working with animals safely; provide proper nutrition to maintain animal performance; know the factors that influence an animal's reproductive cycle; identify environmental factors that affect an animal's performance. This class is a half block class which will last the entire semester earning students a ½ credit toward graduation as well.

The class offered during the second half of 3rd block will be Ag Business Sales and Marketing. The students in this class will: examine skills necessary to obtain gainful employment in agribusiness occupations; examine effects of personality on job performance; use principles to accomplish an agribusiness marketing objective; use sales principles to accomplish an agribusiness objective; use computer technology and documents to manage agribusiness inventory; explore opportunities for marketing of agricultural products throughout the world. This class is also a half block class which will last the entire semester earning students a ½ credit toward graduation as well.

During the fall semester, the Dell Rapids High School agriculture

department will be hosting a student teacher. Alex Louwagie, originally from Redwood Falls, MN, an Agriculture Education major with an Ag Business minor will be spending time observing and teaching students enrolled in the agriculture classes. While in high school, Alex was very active in the FFA and served as chapter secretary, vice president and president. In college, he is a member of the professional agriculture fraternity Alpha Gamma Rho and a member of the Ag Ed Club. We hope that his time at DRHS will be a valuable learning experience and will prepare him for a future as an agriculture teacher.

The sixteen acres of school land is utilized by the agriculture classes as a land lab and allows the FFA members to apply crop production skills. Dean Klein no-tilled in soybeans on May 24 with seed he had left along with some donated by the Dell Rapids CO-OP Grain Co. The land lab will allow students this fall to see and learn about crop production, fertility, pest management and grain marketing. The soybeans will be harvested this fall and the money brought in from the sale of the crop will go into the FFA account to fund all of the FFA activities throughout the year.

The start of summer break found several FFA members serving lunch to students who were enrolled in driver's education during their four days of classroom instruction on June 2,3,6 & 7. Those members helping serve were Cooper Hauglid, Sierra Klein, Brynlee Kriens, Oran O'Meara, Haley Rydel and Karlie TenEyck.

A reward trip was started several years ago to encourage members to get involved in the various activities and events. A point system was developed for each activity and event and once the members earn enough points, they are eligible to go on the trip. This year four members qualified for the trip and they chose to go to Yellowstone National Park June 1-5. Those members qualifying were: Josie Baumberger, Luke Geraets, Sydney Klein and Katie Scherff. The trip consisted of a tour of the Eagle Butte Coal mine near Gillette, WY, going to the Buffalo Bill Center of the West Museums along with looking around Cody, WY, going to the Buffalo Bill Dam and visitor center and the Cody Night Rodeo. Of course going through Yellowstone National Park and stopping at various sights throughout the park was the highlight of the trip.

South Dakota Soil Days and Rangeland Days was held near Murdo on June 14 & 15. The three members who attended were Cooper Hauglid, Brynlee Kriens and Haley Rydell. The first day was spent learning about the various physical properties to look at when evaluating soil and the second day was a contest for students to apply what they learned on the first day. Our team of three placed second and were awarded a silver medal.

The state FFA leadership retreat held at Swan Lake near Viborg was attended by Karlie TenEyck on June 21-24. Karlie and the other participants developed and enhanced their leadership skills and self-confidence through interactive learning. The program featured workshops that helped members discover the value of servant leadership, personal values, personal and team strengths, creating effective teams, Ag advocacy, positive mindset, and conflict resolution. The members will use these new skills and ideas to benefit their local chapters and communities.

The Dells FFA chapter officers decided to have an entry in the Quarry Day parade along with working with Dells Vet Service to have an animal nursery in the city park following the parade. Several members also helped with the pedal tractor pull sponsored by the Dell Rapids Chamber of Commerce. The chapter also had an entry in the Moody County Fair parade in Flandreau on July 21.

Katie Scherff and Karlie TenEyck attended the Washington Leadership Conference in Washington, D.C., to evaluate their personal skills and interests, develop leadership talent and create service plans that will make a difference in their communities. They spent July 26-30 under the guidance of professionals, counselors and FFA staff. They attended workshops, seminars, and small groups, focusing on identifying and developing their personal strengths and goals while undergoing comprehensive leadership training that will help them guide their local FFA



chapters. The capstone of the event was a civic engagement activity where participants applied what they learned to a hands-on activity, which was packing meals for those in need. They also analyzed the needs of their communities, developed wide-ranging

and high-impact community service initiatives and implementation plans with the help of their FFA chapters upon returning home. In 2020 and 2021, the conference was canceled due to theCOVID-19 pandemic. Katie and Karlie also had the chance to experience the history of our nation's capital and tour landmarks including the National Mall, Arlington National Cemetery, Smithsonian Museums and the U.S. Capitol, among others. A tour of the US Capitol was set up through Senator Thune's office. Mr. Wolff, the Dells FFA Chapter advisor, accompanied Katie and Karlie on the trip going a day in advance to the start of the conference to allow for extra sight-seeing. They were able to go through the Holocaust Museum, go to the National Archives



Museum, which is the home of the Declaration of Independence, the Constitution and the Bill of Rights, go to Mt. Vernon and tour the mansion, go to the Library of Congress, tour Ford's Theatre and go to the top of the Washington Monument. Before the return flight on Sunday, they attended the church service at the Washington National Cathedral.

Any student enrolled in a high school agriculture education class during the fall semester or the spring semester is eligible to join the FFA organization and participate in the various activities and events throughout the year. ## STUDENT HEALTH

#### **Food Allergies:**

In the interest of our youngest students with food allergies, Dell Rapids Elementary School continues to be **Peanut Aware**. We ask that students and parents, please, NOT bring peanuts or peanut products into DRES or send them as snacks on field trips. We would greatly appreciate your assistance in helping us keep our students with food allergies healthy and safe.

#### **Latex Allergies:**

To protect our students with allergies to latex, Dell Rapids School District asks that latex balloons not be brought to school.

#### **Immunization Records:**

All new students to the school district (Early Childhood, K-Prep, Kindergarten, transfer, and foreign-exchange students) must have on record in the school office an up-to-date immunization record and a copy of his/her official birth certificate by the first day of school.

#### 6th Grade Immunization Requirements:

Since the 2016-2017 school year, the South Dakota Department of Health has included in their administrative rules the requirement of both the Tdap (Tetanus, Diphtheria, Pertussis) and MCV4 (Meningococcal ACYW) vaccines for entry into the 6th grade. Vaccine requirements for Kindergarten entry have been in place for many years. This will be the fifth year of this such requirement for 6th grade entry in South Dakota. Therefore, school entry requirements for South Dakota 6th grade students include:

✓ One dose of Tdap vaccine

✓ One dose of MCV4

These requirements apply only for 6th grade entry and transfer students 6th through 12th grade. If a child is 10 years old when entering the 6th grade, they have 45 days after their 11th birthday to be vaccinated.

#### **Medications:**

All students requiring medication administration during school hours must complete the proper forms. Please see or email the school nurse (jill.dvorak@k12.sd.us) with any questions you have.

## TOBACCO/ALCOHOL & DRUG POLICY

The Board of Education prohibits the use of all tobacco products in any building, vehicle, or bus owned/or operated by the school district.

## **ACCIDENT INSURANCE**

The Dell Rapids schools do not carry insurance to pay for school related accidents. If an accident occurs, costs from the accident are the responsibility of the person involved in the accident.

Individuals are encouraged to carry accident insurance.

The federal education law called the Elementary and Secondary Education Act (ESEA) requires that all parents in a Title I school be notified and given the opportunity to request information about the professional qualifications of classroom teachers instructing their child. If you are interested in this information, you may send your request to the building principal who will provide a response.

#### SCHOOL MEALS

During COVID, schools had Federal flexibilities so they could serve free meals to all students. That option has now expired, and the Dell Rapids School District can no longer serve free meals to all students. Instead, families will do what they did before COVID.

Children are automatically eligible for free meals if anyone in their household gets SNAP, TANF, or FDPIR benefits. Families will receive a letter from the school if the state has directly certified their child(ren) as eligible for free meals. Families who receive SNAP, TANF, or FDPI benefits, and who have not received a direct certification letter, should fill out a free and reduced-price meal application with their assistance information.

Children experiencing homelessness, children in foster care, runaway youth, or children of migrant workers all qualify for free school meals when their household fills out an application.

Children can also qualify for free or reduced-price meals through an application if their household's income is under a certain limit. For school year 2022-23, families who have not received a letter from the school informing them they have been directly certified for free meals, and who may qualify for free or reduced-price meals based on their income, will need to submit a free and reduced-price meal application. The school will take applications and use

family income to qualify students for free, reduced-price, or paid meals. The latest income guidelines can be found on the school's website in the free and reduced-price meal FAQ's, online at https://www.fns.usda.gov/cn/fr-021622, or contact the school for more information.

Children who do not qualify for free or reduced-price meals may pay full price for a healthy breakfast or lunch at school. Full-price student breakfast is \$1.50, and full-price student lunch is \$2.60 for grades K-4 and \$2.80 for grades 5-12. Even at full price, school breakfast and lunch are still an excellent bargain. The school contracts with Lunchtime Solutions to provide school meals, and LSI's nutrition staff are dedicated to fueling students' minds and bodies for learning.

# SECTION 504 OF THE REHABILITATION ACT OF 1973 Public Notice Dell Rapids School District 49-3

Section 504 is an Act which prohibits discrimination against individuals with disabilities in any program receiving federal financial assistance. The Act defines a person with a disability as anyone who:

- has a mental or physical impairment which substantially limits one or more major life activities (major life activities include activities such as caring for one's self, performing manual tasks, walking, seeing, hearing, speaking, breathing, learning, and working);
- 2. has a record of such impairment; or
- 3. is regarded as having such impairment.

In order to fulfill obligations under Section 504, the Dell Rapids School District has the responsibility to avoid discrimination in policies and practices regarding its personnel and students. No discrimination against any person with a disability should knowingly be permitted in any of the program and practices of the school system.

The school district has responsibilities under Section 504, which include the obligation to identify, evaluate, and if the student is determined to be eligible under Section 504, to provide appropriate educational services. If the parent or guardian disagrees with the determination made by the professional staff of the school district, he/she has a right to a hearing with an impartial hearing officer.

The Family Educational Rights and Privacy Act (FERPA) also specify rights related to educational records. This Act gives the parent or guardian the right to: 1) inspect and review his/her child's educational records; 2) make copies of these records; 3) receive a list of all individuals having access to those records; 4) ask for an explanation of any item in the records; 5) ask for an amendment of any report on the grounds that it is inaccurate, misleading, or violates the child's rights; and 6) a hearing on the issue if the school refuses to make the amendment.

## TITLE IX

Title IX requirements and training. New Title IX Federal Regulations have been in place since Aug. 14, 2020. The regulations require that a school district's Title IX coordinator receives training on how to serve impartially and without bias pursuant to § 106.45(b)(1)(iii). In addition § 106.45(b)(10)(D) requires all training materials to be published on the Dell Rapids School District Website. Our Title IX Coordinator, Ms. Julie Wynja, was trained through the State Bar of South Dakota, School Administrators of South Dakota (SASD), and Associated School Boards of South Dakota (ASBSD). Training materials for this training utilized resources from a number of sources including the U.S. DOE, NSBA/COSA, and other resources.

All DRPS staff participated in Mandatory Title IX Compliance training. The training was provided by SafeSchools (Vector Solutions).

Steve Helgeland, Special Education Director of the Dell Rapids School District, in order to fulfill obligations of the Education for All Handicapped Children Act (EAHCA, P.L. 94-142) and the Individuals with Disabilities Education Act (IDEA, P.L. 101-476) is required to inform and provide full educational opportunities to all individuals with disabilities ages birth through twenty-one.
