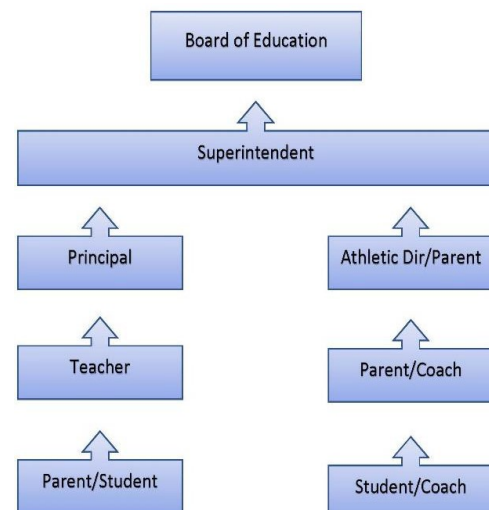

# STUDENT HEALTH

## Food Allergies:

In the interest of our students with food allergies, Dell Rapids Elementary School continues to be **Peanut Aware**. We ask that students and parents, please, not bring peanuts or peanut products into DRES or send them as snacks on field trips. We would greatly appreciate your assistance in helping us keep our students with food allergies healthy and safe.

## Latex Allergies:

To protect our students with allergies to latex, Dell Rapids School District asks that latex balloons not be brought to school.

## Immunization Records:

All new students to the school district (Early Childhood, K-Prep, Kindergarten, transfer, and foreign-exchange students) must have on record in the school office an up-to-date immunization record and a copy of his/her official birth certificate by the first day of school.

## New Immunization Requirements:

The South Dakota Department of Health has revised its administrative rules to require both the Tdap (Tetanus, Diphtheria, Pertussis) and MCV4 (Meningococcal ACYW) vaccines for entry into the 6th grade beginning with the 2016-2017 school year. Vaccine requirements for Kindergarten entry have been in place for many years, but this will be the first such requirement for middle school entry in South Dakota. With this change, school entry requirements for South Dakota 6th grade students include:

✓ One dose of Tdap vaccine

✓ One dose of MCV4

These requirements apply only for 6th grade entry and transfer students 6th through 12th grade. If a child is 10 years old when entering the 6th grade, they have 45 days after their 11th birthday to be vaccinated.

## Medications:

All students requiring medication administration during school hours must complete the proper forms. Please see the school nurse with any questions you might have.

## TOBACCO/ALCOHOL & DRUG POLICY

The Board of Education prohibits the use of all tobacco products in any building, vehicle, or bus owned or operated by the school district.

## ACCIDENT INSURANCE

The Dell Rapids schools do not carry insurance to pay for school related accidents. If an accident occurs, costs from the accident are the responsibility of the person involved in the accident. Individuals are encouraged to carry accident insurance.

## MY CHILD'S TEACHER

What do I know about my child's teacher? The federal education law called the Elementary and Secondary Education Act (ESEA) requires that all parents in a Title I school be notified and given the opportunity to request information about the professional qualifications of classroom teachers instructing their child. If you are interested in this information, you may send your request to the building principal who will provide a response.



## ACTIVITY TICKET POLICY

A family all-season athletic pass will be available for \$100.00. A family pass will include up to two adults (must be a parent or guardian) and all K-12 children living in one household. The cost of an individual high school student activity ticket is \$20.00, and the cost of a middle or elementary student activity ticket is \$15.00.

All students and families had an opportunity to buy activity tickets on registration day. Activity tickets allow all-season admittance to most athletic events conducted by the Dell Rapids Public Schools and as identification for student prices at other activities.

Other options for admittance to school activities include the adult 10-punch athletic pass for \$30.00 or adult all-season athletic passes for \$50.00 each. Regular contest athletic competition admission prices are \$5.00 for adults and \$3.00 for students, and \$6.00 and \$4.00 for double-header games, respectively. Senior Citizens (Age 62 & over) who are residents of the Dell Rapids School District can receive free admission to most Dell Rapids Public School athletic events. A card will be required to receive free admission. Free season passes may be picked up at the District office.

## DELL RAPIDS FINE ARTS BOOSTERS

The Fine Arts Boosters support band, choir, drama, journalism and quiz bowl at Dell Rapids High School and Middle School. We are a very small group (4 of us) and we can always use your help! We host a quiz bowl supper, pops concert supper, and a dinner theatre for the spring play, plus we provide support for the marching band at their parade competitions.

Last year, our fundraising efforts helped us contribute \$7000 toward the purchase of new stage curtains. In the past, we have bought the new marching band banner, shirts for the quiz bowl team, a camera and

lens for journalism and the coffee cart for the drama club to raise their own money, camp and private lesson scholarships, and more.

Whether you helped us by baking a pan of bars or donating your time at an event, we appreciate your help! Please consider joining us this school year. We are especially in need of people to take over as officers. Volunteer forms went out with the back-to-school registration packets and can be turned in on registration day. Thank you for helping us support the fine arts at DRHS and DRMS!

## BAND INSTRUMENT LEASE

Parents/Guardians (and students age 18 or older) may lease school owned band instruments for student use in accordance with school policy IGDE. The lease fee will be \$75.00 per school year. The lease fee will be waived for students playing a school-owned instrument at the director's request or directive. The lease fee may also be waived by the Superintendent based upon the unique circumstances of the parents/guardians/student. It is the intent of the Board of Education that no student shall be denied participation in the band program due to inability to afford a musical instrument or to lease a District owned musical instrument. Students (except graduating seniors) may keep the school-owned instrument

over the summer for an additional lease fee of \$37.50. Checks should be made payable to the Dell Rapids School District and given to the student's band director.



# STUDENT ATTEND NATIONAL FCCLA CONFERENCE

Over 8,600 Family, Career, and Community Leaders of America (FCCLA) members, advisers, and guests from across the nation traveling to Anaheim, CA, for the 2019 National Leadership Conference June 30 - July 4. Local Dell Rapids FCCLA member, Faithe Larson, qualified to participate in the Recycle and Redesign competitive event at state conference held in April. She received a silver rating on her presentation. Attendees to the conference were able to explore different career paths, listen to keynote speaker Kyle Scheele who inspired members to live a better story, and to network with members from across the country. Faithe also attended Disney leadership trainings on costuming and culinary. Adviser, Beverly Rieck, was one of 7 adults from our state to serve as an evaluator for competitive events. FCCLA is a dynamite and effective national student organization with the goal to help men and women grow as youth leaders in their communities. It is the only career and technical school organization with the family as its central focus. Members pursue personal, family, work, and societal issues as they grow and develop into strong leaders in their families, careers, and communities.

# Ag In Action

The FFA started the summer break off serving lunch to the students enrolled in driver's education. Karlie Klein, Luke Randall and Noah Randall served the lunch the four days of classroom instruction. Mason Machmiller, chapter vice president attended the state FFA leadership retreat held at camp Bob Marshall near Custer on July 9-12. FFA members attending the retreat developed and enhanced their leadership skills and self-confidence through interactive learning. The program featured workshops that helped members discover the value of servant leadership, character, attitude, a focused vision, communication, trust, and responsibility. They will use these new skills and ideas to benefit their local chapters and communities. Retreat attendees also participated in a service learning project at Camp Bob Marshall along with attending the laser light show at the Crazy Horse Memorial.

## Courses offered in Agriculture Education fall semester:

It seems like the summer break goes by faster each year and will be over soon and we will be returning to classes. A half block class of Wildlife and Fisheries is one of the courses being offered in Agriculture Education for the fall semester. The students in this 1st skinny class will have the opportunity to learn about the importance of managing fish and wildlife and understand the importance habitat plays in their populations, identify key factors including economic and social issues related to fish and wildlife and identify life patterns of fish and wildlife. The other skinny class offered during 1st block will be Ag Processing Technology and will also last the entire semester. The main focus of this class is on the processing of various agriculture products. Dairy processing has students analyzing the quality factors of dairy products including fluid milk, butter, yogurt, cheese and ice cream. Using a hand-crank butter churn from the Old Courthouse Museum, the class will make home-made butter and sample it. Ice cream will also be made during class using an electric ice cream maker. The slaughter process, quality grading, yield grading and inspection are all parts of the meat processing unit. Other aspects of agricultural processing are also covered included handling, transporting and marketing along with methods of processing, preserving, storing and new technology used in processing. Students enrolled in Introduction to Agriculture, Food and Natural Resources during 2nd block will explore the role of the FFA organization in Agriculture Education, define and discuss the concepts of natural resources, demonstrate an understanding of animal science systems, demonstrate an understanding of plant structure and function, relate basic food science technology principles to production agriculture, summarize basic food science technology, and summarize basic principles involved in agricultural systems technology. Those students will also have the opportunity to learn about shop tools and shop safety, project design and construct a small wood project. Another section of Wildlife and Fisheries will be offered during the first half of 3rd block covering the same material as the 1st skinny class. Ag Power Technology will be offered during the second half of 3rd block and since both of these classes are a half-block in length, they will last the entire semester. The topics covered in Ag Power Technology consist of analyzing

various engine information in the classroom before going to the shop to work on engines. The classroom instruction will include safety, tools, fasteners, principles of operation, 2 and 4 cycle engines, engine performance, emission controls, carburetion, ignition systems, lubrication systems, cooling systems and preventative maintenance and troubleshooting. The students will then have the opportunity to work on their own engine projects ranging from general maintenance to complete over-hauls. Any student enrolled in an agriculture class during the fall semester or the spring semester can join the FFA organization, which can help prepare students for premier leadership, personal growth and career success.

The sixteen acres of school land is utilized by the agriculture classes as a land lab and allows the FFA members to apply crop production skills. Just like many of the farmers in the state, we experienced wet conditions that did not allow us to plant but Troy Randall was able to work most of the field and seeded rye for a cover crop.



## SCHOOL CALENDAR TO INCLUDE BUILT-IN SNOW DAYS

Although we are in the middle of a beautiful summer season, winter weather is right around the corner. Last year the district had several emergency days which prompted a discussion about implementing built-in calendar days. A survey of district parents showed 82% supported moving forward with the idea, therefore, we amended the 2019-2020 calendar to include three days designated for making up missed classroom time. The following stipulations will be considered:

- The first full day of school missed for weather will be forgiven.
- Additional snow days will be made up by the dedicated built-in days, if they take place at least 7 days in advance.
- The district will notify parents of the intent to utilize the built-in day as soon as possible, but again, there will always be a week notice.
- Specific dates include February 17, March 19, and April 13.

Please make reference to these dates as our South Dakota weather is never quiet and I anticipate putting our new policy into place at some point this year.

## SCHOOL MEALS

The Dell Rapids School District participates in the National School Lunch and Breakfast Programs. Lunchtime Solutions provides complete, well-balanced meals that are attractive and satisfying to students. All students are encouraged to enjoy the nutritious meals that include an all-you-can-eat salad bar.

Students may buy breakfast for \$1.45 at each school. The daily price for student lunch at the elementary school is \$2.80, and the daily price for student lunch at the middle school and high school is \$2.90. The price for an extra milk, or milk for elementary breaks, is \$.50. An extra entrée is \$1.80, and an extra pizza slice is \$1.90.

Applications for free and reduced price meals were mailed to each family and are also available in the principals' offices. Parents who have not received a direct certification notice, and who wish to apply for free or reduced price meals for their children, should return a completed application form to the business office.

A selection of a la carte items is available for purchase in the middle school and high school after the purchase of a complete lunch. Parents are able to place restrictions on student purchases of a la carte items, such as no purchasing of a la carte items or allowing a la carte purchases with cash only. To place account restrictions, parents should complete a Restricted Meal Account Request Form and return it to the school business office.

The district uses NutriKids computer software

for record keeping. Each student has his/her own lunch account, and the district requires payment in advance for students to purchase meals or a la carte items. Any dollar amount can be deposited toward future purchases. It is recommended that deposits into students' accounts be made online or by check. Meals may also be purchased with cash at the point of service.

On the MySchoolBucks.com website, parents are able to view their child's account balance, access their child's eating history report for the past thirty days, and sign up for low balance notifications. The MySchoolBucks.com website is also a convenient, easy and secure online prepayment service to deposit money into a child's school meal account. There is no fee for making meal deposits online. More information on how to access this service is available on the district website at [dr-k12.org](http://dr-k12.org).

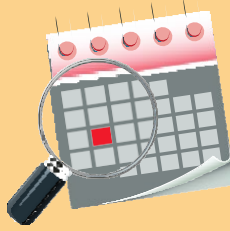
