**20-083** Motion by Weiland, seconded by Traill, to approve a resolution authorizing the execution, terms, issuance, sale and payment of limited tax **Capital Outlay certificates** in the aggregate principal amount of not to exceed four million dollars (\$4,000,000) to provide funds for school improvements including: (1) Middle School/High School Interior Renovations and Exterior Improvements, (2) furnishing and equipping the same, (3) other school improvements, and (4) the costs of issuing the certificates.
